## Good Shepherd Scholarship (provided by the Diocese of Lincoln)

This scholarship is offered by the Diocese of Lincoln through funds received during the Joy of the Gospel campaign. GSS Scholarship rewards are earned based up on adjusted gross income. K-12 graders are eligible. ## Hastings Catholic Schools (HCS) Good Angel Scholarship (provided by HCS)

The HCS Good Angel Scholarship is made up of funds from many different "scholarships" provided by donors and some general budget dollars from the school. The HCS Good Angel Scholarship is awarded based upon adjusted gross income and/or need and/or may be awarded simply because you have had a life-changing event. Those who qualify for the Good Shepherd Scholarship do not qualify for the HCS Good Angel Scholarship. Preschool-12<sup>th</sup> graders are eligible to receive these funds.

The application on FACTS is required for this tuition reduction option.

HCS encourages you to also contact your parish Pastor to visit about funds also available through your church. In many cases, the church is able to help offset tuition costs.

The HCS Good Angel Scholarship deadline through FACTS is October 31 of each year BUT if you have a life-changing event or are struggling to cover tuition costs, you may inquire about receiving funds at any time throughout the year. # COMPLETING THE APPLICATION:

You will need to create your own personal account prior to completing the application.

The following information will be needed to complete your application:

- Copies of all 2021 IRS Federal Form 1040, 1040A, or 1040-EZ U.S. Individual Income Tax
  Return
- Copies of all 2021 W-2 Wage and Tax Statements
- Copies of all supporting documentation for household Non-Taxable Income such as SSI,
  Welfare, Child Support, Food Stamps, Worker's Compensation, and TANF
- Copies of Business Tax Document if you own a business (ie: Sole Proprietor, Partnership, LLC only)
- Payment of your nonrefundable \$35 application fee

#### **CONFIDENTIALITY:**

Your application information will remain confidential and is processed by a third-party company called FACTS Management Company. The only information that the Diocese of Lincoln and/or Hastings Catholic Schools receives from your application is a "yes" or "no" on whether or not you are eligible for the above scholarships.
